Pricing power



Sector Focus Risk: The Fund may invest a significant portion of its assets in one or more sectors, including Consumer Discretionary and Consumer Staples, and thus will be more susceptible to the risks affecting those sectors than funds that have more diversified holdings across several sectors.

Glossary

30-Day SEC Yield: is a standard yield calculation developed by the Securities and Exchange Commission (SEC) that facilitates fairer comparisons of funds. The figure reflects dividends and interest earned by the securities held by the fund during the most recent 30-day period, net the fund's expenses.

Gen-Z: Generation Z comprises people born between 1996 and 2010.

Median 30-Day Bid/Ask spread: The median 30-day bid/ask spread is the percentage by which the the fund's ask price exceeds its bid price over the last 30 calendar days.
